






#### **VOTING PATTERNS**





- February 2015 Bond Proposal
  - Revised analysis of tax rate produced by passage of bond and growth in property values
  - Actual 1.06% growth in assessed value in 2015
  - 1.0% growth in assessed value in 2016
  - 2.0% growth in assessed value in 2017
  - 2017 total tax rate estimate \$2.19 per \$1,000 assessed value


